GUEST SPEAKER: Derrin Watson, Esq., APM

S. Derrin Watson, J.D., received his bachelor's degree in accounting from BYU. He later graduated fifth in his class from UCLA Law School. Formerly the tax partner of a law firm in Beverly Hills, Derrin is now a tax attorney in solo practice in Santa Barbara, CA and works with and speaks for SunGard.

Derrin has been involved with qualified plans since 1977, and had his first case involving controlled groups shortly thereafter. He has maintained a strong interest in the controlled group affiliated service group arena. He is the leading authority on controlled group, affiliated service group and leased employee issues.

Derrin lectures frequently for SunGard, ASPPA and other professional organizations. He is an Editorial Advisor for the Journal of Pension Benefits and has written many articles for that publication and The ASPPA Journal.
