Speaker: Susan A. Hensley Deputy Regional Director, Department of Labor

Susan A. Hensley is the Deputy Regional Director in Dallas for the U.S. Department of Labor, Employee Benefits Security Administration (EBSA). She began her career as an auditor with EBSA in 1991 and has over eighteen years of experience in EBSA's enforcement activities. As Deputy Regional Director, Ms. Hensley oversees the region's civil enforcement activities in the five-states of Texas, Oklahoma, Louisiana, Arkansas and New Mexico.

Her undergraduate studies were completed at the University of Louisiana-Lafayette, with a Bachelor of Science in Business Administration, major in accounting. Ms. Hensley earned the degree of Juris Doctor from Southwestern University School of Law in Los Angeles, and was admitted to the State Bar of Texas.
