Single User subscription terms: Each online edition single user subscriber is issued a unique login for one person only. **Single-user licenses are not valid for more than one person.**

Multiple User subscription terms: Each online edition concurrent user license (3, 5, 10, or unlimited) is issued one login for the company. The 3-, 5-, and 10-user online concurrent user licenses are only available for one site location. **Access for multiple locations must be purchased under the unlimited user license (EB-7012).**

Each online edition purchase is for 12 full months of online access starting from date of account activation. For example, if you have online access expiring in April 2012, renewing your current subscription now means your current login will be valid through April 2013.

Please Note: The 2012 Print version of the ERISA Outline Book will be released in March, 2012. Upon release of the Print version in March all pre-orders will be immediately fulfilled.

ORDERS

If you purchase the Print Edition only, the Online Edition purchased at a later date will be the list price. If you purchase the Online Edition only, purchase of the Print Edition at a later date will be the list price. The discounted pricing is only applicable if purchasing the Print and Online Edition Package (EB-2012).

Online Edition purchasers (EB-3012, EB-4012, EB-5012, EB-6012 & EB-7012) of *The ERISA Outline Book Online Edition* will receive log-in information 3-5 business days after purchase. Access to the online edition will be available for one year (365 days) from the date the account was activated. **The 2012 content of the ERISA Outline book will be released in March 2012.**

SHIPPING (EB-1012 and EB-2012)

Customers must allow two to three weeks for shipping unless rush options are indicated on this order form. Air Rush 2nd Day orders are shipped 2nd day delivery. Overnight shipping is available for a total of two times Air Rush 2nd Day total. International shipping is available. Delivery time will depend on country of destination and courier service. Shipping fee will be 20% of the order total.

RETURNS

Online editions are non-refundable once online access has been granted. The print editions (EB-1012 and EB-2012) may be returned for a refund minus a 10% restocking fee within 30 days of purchase provided the condition is unused; customer pays shipping on returns unless product is defective.
