**Single User subscription terms:** Each online edition single user subscriber is issued a unique login for one person only. **Single-user licenses are not valid for more than one person. Sharing a single user license with anyone other than the main user is a breach of the Agreement Terms.** Single-user licenses are not transferrable without written permission from the original named user.

**Multiple User subscription terms:** All EOB Online Subscriptions are valid for 365 days from purchase date. The 5, 10, and 50-user licenses are assigned to specific individuals at your company. **Multiple user licenses are not valid for more than one person. Sharing a multiple user license with anyone other than the assigned user is a breach of the Agreement Terms.** After completing your purchase, you will be contacted to provide this list of users as well as an administrator contact at your company. The administrator contact is responsible for providing the initial list of users. They will also have access to the ERISA Outline Book system and are responsible for the revocation of access for any current users. If the administrator contact also needs access to the ERISA Outline Book content, they should be included on the list of users to be assigned one of the available licenses. Revoked licenses will remain inactive/unassigned for the remainder of the 365-day subscription. Requests to transfer blocked licenses will be handled on a per-request basis and are subject to a \$150 processing fee. The administrator contact will ensure all named users have ASPPA accounts. ### SHIPPING (applies to EB-1023 only)
