Single User subscription terms: Each online edition single user subscriber is issued a unique login for one person only. **Single-user licenses are not valid for more than one person. Multiple User subscription terms: Online edition concurrent user license (3, 5, 10, or unlimited) will receive access to the product through their MyASPPA account shortly after purchase. **Multi-user licenses apply to the company; users tied to the license-holding company will automatically receive access. Users must create an ASPPA account to receive access if they do not have one already. Creating an account is free and you do not need to be an ASPPA member.**

Each online edition purchase is for 12 full months of online access starting from date of account activation. For example, if you have online access expiring in April 2019, renewing your current subscription now means your current login will be valid through April 2020.

ORDERS

Online edition purchasers (EB-3000, EB-4000, EB-5000, EB-6000, and EB-7000) of *The ERISA Outline Book Online Edition* will receive access to the product from their MyASPPA account shortly after purchase. Access to the online edition will be available for one year (365 days) from the date the account was activated unless the subscription is renewed.

SHIPPING (applies to EB-1018 and EB-2000 only)

Customers must allow two to three weeks for shipping unless rush options are indicated on this order form. Air Rush 2nd Day orders are shipped 2nd day delivery. Overnight shipping is available for a total of two times Air Rush 2nd Day total. International shipping is available. Delivery time will depend on country of destination and courier service. RETURNS
